b) Jackson V. Horizon Holidays 1975.

The plaintiff booked a holiday for himself, his wife and their two children. The total cost of the holiday including air fares, was1, 200 pounds. The holiday provided failed to meet the description given in the defendant's brochure in a number of vital aspects. The plaintiff brought an action claiming damages, including a claim for his own personal disappointment and that of his wife and children for the failure of the holiday to meet the description given by the defendant company. The trial judge allowed when assessing the damages payable by the defendants (1,100 pounds) for the disappointment of the plaintiff alone and for the disappointment of his wife and family. The defendants appealed against the quantum of damages. As a lawyer, advice the defendant giving the rationale for your answer.

#### Question 5

- a) A partnership may be formed through agreement, simple, or under deed, or even may be implied from the conduct of the parties concerned.
